Matthew, a 77-year-old man with Parkinson's disease and Parkinson's disease dementia, also has chronic kidney disease, heart disease, hypertension, and leg oedema. He is no longer speaking meaningfully and often appears agitated, which concerns his wife and daughter, who are his primary caregivers. He struggles with swallowing, sometimes choking on food and finding it difficult to take medication, particularly Sinemet, which no longer seems effective. Matthew had previously expressed a desire for comfort-focused care, avoiding invasive treatments like a feeding tube.

Charlie 50yrs old male, diagnosed 19yrs old with PPMS, married to Jane with a 14yr old son Sam, now has advanced MS (EDSS 8.5), extensive care package, living at home, family are struggling with his increased needs, he has had multiple admissions with urine infections and now has pressure sores secondary to the spasticity and dystonia.

Motor neurone disease (MND)

Dr Emma Husbands, Rachael Marsden, Sean White & James Townsend

During a MND support group the topic of discussion moved to how MND impacts on every aspect of the lives of people living with MND and that of their families. Living with MND affects the previous relationships and roles people have within their family homes at a physical, environmental and emotional level. The consequences of MND can make intimacy a challenge whether that be in relation to the ability to express themselves or changes to the physical environment of the home. People living with MND can perceive a loss of agency but expressed how they still want to have control over their care and how they wish to live their lives with MND. The group discussed how supporting HCPs can both support and hinder their ability to make choices that are aligned with their values, including the option to accept/take risks.

- How to support people with MND to make positive risk choices.
- Supporting people with MND to continue to engage in intimate relationships.
- Facilitating people with MND to make choices about their lives and care that are aligned with their own values.
- Recognising the support that caregivers need to meet the needs of people with MND and themselves.
